# SUNSHINE COAST ART GROUP

The Sunshine Coast Art Group has been a creative hub for the local community for over 50 years. Our club is **100% run by volunteers** so all our members are expected to volunteer from time to time to ensure the continued operation of the club and enable us to maintain our low fees.

## Health & Safety Policy Agreement

- It is a requirement (ratified at the 2013-4 AGM) that all members sign the attendance book when attending a working session. This is for the emergency services information, should there be a safety incident. This is in addition to Covid registration with QR code.
- **Only children under adult supervision are permitted on SCAG premises. This applies for all events/open days. Children under the age of 18 are only able to participate in workshops/classes under the supervision of a teacher/tutor (SC Art member) that has satisfied the criteria of and been approved by the Management Committee. All volunteers and helpers involved in these workshops/classes must have Blue Cards, sighted and recorded by the Management Committee.**
- The Management Committee has drawn up Health and Safety procedure acknowledgment forms. All members are required to read and sign these forms confirming their agreement to abide with the association's Health and Safety practices.
- Members (art/music/sewing) who use the art studio area, have fewer hazardous products and conditions than those of the pottery members. However, the artists must be aware that when they are working turpentine and pastel dust can be considered hazardous. All members using the studio are expected to leave a tidy safe working area when they finish.
- **There is to be NO photography during Life Drawing sessions, for privacy reasons. All mobile phones are to remain in bags.**
- **All members who wish to use their electrical equipment, including electric leads, must have them tagged by a qualified electrician.**
- Pottery studio: **NO sweeping ONLY** vacuuming or damp mopping. There are many areas which they must be aware of their Health and Safety obligations.  
These are basically: **Healthy and safe workshop practices & Healthy and safe firing practice.**
- The Pottery Leader will give all members instruction of the workshop practice we require of all members. This will include clay and glaze handling, storage, disposal and workshop cleaning.
- To fire the kilns, members **MUST** attend teaching sessions to qualify as a "**Firer**". Only those registered as a **Firer** can use the kilns. **GAS KILNS** must have two signed persons present for the first and last two hours of the scheduled firing.
- All firing must be approved by the Pottery Leader.

### **OUR POLICY IS AS FOLLOWS:**

- (a) **For unsafe studio practice, our policy is to give all members notice of the incident. To give One Verbal and One Written warning to any member or members. If the unsafe habit persists the membership will be terminated under Rule 9(3) (d) of our Rules. The safety of all members is our priority.**
- (b) **For unsafe firing practice, our policy is that the Leader will immediately disqualify that member from firing and encourage them to undertake a refresher course to requalify.**
